

**Freedom of Information Act (FOIA)  
Public access to Normal Township information**

Normal Township, a government body established in 1857, provides the statutory responsibilities of road maintenance, property assessment and general assistance. We further serve the community through an emergency assistance program for families, the Senior Health Insurance Program (SHIP), and the Adult Recreation Center (ARC) for people age 55 and over. We also currently provide annual grants to the Community Health Care Clinic for medical treatment for the uninsured in Normal Township, to the Town of Normal for Before & After School Care, and to Peace Meal to help provide meals to local seniors.

In accordance with the Illinois Freedom of Information Act (FOIA), Normal Township provides residents access to public records and documents. We accept requests in person at our office, through the mail, by fax, and via e-mail. Please be specific in what you are requesting and include a mailing address and a phone number where you can be reached.
